

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.allthingsprofessionallc.com](http://www.allthingsprofessionallc.com), and ALLTHINGSPROFESSIONAL LLC and governs data collection and usage. ## Collection of your Personal Information
